On behalf of all ComEd employees and customers, thank you for your assistance during what has proven to be a remarkable restoration effort.

This was our most extensive restoration project since last August's record-setting storms. Among the worst storms in a decade, a combination of approximately 88,000 lightning strokes and winds as high as 94 miles per hour caused approximately 200 damaged utility poles, more than 150 damaged transformers and the replacement of more than 30 miles of electric wire. Our crews were working 16-hour shifts and throughout the night to restore service, and the additional support you provided enabled us to restore power to all but a handful of customers within three days.

Thank you for your prompt response and for your crews' excellent performance on ComEd's behalf.
